What is NYCLASS?

General Information

New York Cooperative Liquid Assets Securities System (NYCLASS) is a short-term, highly liquid investment fund, designed specifically for the public sector. NYCLASS provides the opportunity to invest funds on a cooperative basis in short-term investments that are carefully chosen to yield favorable returns while striving to provide maximum safety and liquidity.

Who Can Participate?

Participation is available to any municipal corporation or special-purpose district empowered under New York state statute including counties not within the City of New York, cities, towns, villages, school districts, boards of cooperative educational services, and fire districts. Also eligible are county or town improvement districts where the respective county or town is required to pledge its faith and credit for the district's debt service.

NYCLASS is subject to the Municipal Cooperation Agreement Amended and Restated as of March 28, 2019 (the Agreement) and is structured in accordance with New York State General Municipal Law (GML), Article 3-A and Article 5-G, Sections 119-n and o, and Chapter 623 of the Laws of 1998. All NYCLASS investment and custodial policies are in accordance with GML, Sections 10 and 11 (as amended by Chapter 708 of the Laws of 1992). The Agreement is between the Village of Potsdam (Lead Participant) and each district and/or municipal corporation that formed the original NYCLASS fund or that subsequently elects to participate; all parties to the Agreement are collectively referred to as "the Participants."

The Agreement is administered by an elected Governing Board (the Board) of up to fifteen members. The Governing Board is responsible for:

- Administering all aspects of the Agreement.
- Entering into appropriate contracts to assist in the management of the Agreement.
- Monitoring compliance with the investment policy, maturity limitations, and reporting and disclosure requirements established under the Agreement.
- Testing the investments made pursuant to the Agreement, at least once a month, for sensitivity to changes in interest rates.
- Disclosing to Participants any rating or change in rating from a nationally recognized statistical rating organization.

A Board member must be either a Participant's Chief Fiscal Officer, other designated officer, or employee of the Participant who has knowledge and expertise in financial matters

A The NYCLASS Municipal Cooperative Agreement is administered by an elected Governing Board (the Board) of up to fifteen members. A Board member must be either a Participant's Chief Fiscal Officer, other designated officer, or employee of the Participant who has knowledge and expertise in financial matters. The Board retains the services of Public Trust Advisors, LLC to serve as the Program Administrator and Investment Advisor.

Q Who is eligible to use NYCLASS?

A Participation is available to any municipal corporation or special-purpose district empowered under New York state statute including counties not within the City of New York, cities, towns, villages, school districts, boards of cooperative educational services, and fire districts. Also eligible are county or town improvement districts where the respective county or town is required to pledge its faith and credit for the district's debt service.

2. Q. What BOCES Board seats are up for election in 2023?

A. Four (4) seats are up for election; those currently held by Christopher Hockey, Lisa O'Reilly, Joan Reeves, and Christine Gregory.

3. Q. What is the term of office for a BOCES Board member?

A. The term of office for the seats held by Christopher Hockey, Lisa O'Reilly, and Joan Reeves are for three (3) years. The term of office for the seat held by Christine Gregory is for one (1) year.

4. Q. When is the election of BOCES Board Members to take place?

A. April 17, 2023.

5. Q. Where must the election of BOCES Board Members be held?

A. In each component school district at a meeting of the local Board of Education to be held on April 17, 2023.

6. Q. How and when are BOCES Board Members to be nominated?

A. By resolution of the board of education of one or more component school districts, to be transmitted to Theresa Smith, the Clerk of the BOCES, in writing no later than 4:00 pm on March 10, 2023.

7. **Q. How are component school districts notified of the slate of candidates?**
- A. As required by regulation, the Clerk of the BOCES will send an official election ballot containing the name and address of each candidate to the clerk of the board of each component school district by April 3, 2023. Copies of the ballot will be sent to all board of education presidents and superintendents.
8. **Q. How many votes may each component school district cast?**
- A. One vote for each vacant board position to be filled. No more than one vote may be cast for any individual candidate.
9. **Q. May a component school district cast a “bullet” vote (i.e., vote only for one candidate where there is more than one vacancy)?**
- A. Yes. Component school districts are “entitled to” one vote for each vacant office, but there is no requirement that they cast one vote per vacancy.
10. **Q. How are the winning candidates determined?**
- A. The candidates receiving a plurality of the votes cast are elected. Candidates are elected in order of the greatest number of votes received until all vacancies are filled.
11. **Q. When do the new Board members take office?**
- A. The four (4) candidates with the highest number of votes take office on July 1, 2023.
12. **Q. What happens if the component Board of Education is unable to obtain a quorum on the day designated for the BOCES election, or otherwise fails to adopt a board resolution voting on the candidates?**
- A. The ballot of the component school district will be treated as void, and the candidates receiving a plurality of the votes actually cast on the day of the election are elected.
13. **Q. How is representation from all districts encouraged?**
- A. Representation on the OCM BOCES Board of Education is determined by law and by tradition. The law governing BOCES Boards of Education indicates that no Board of Education can have more than one representative. The tradition in this BOCES since the merger of the Onondaga-Madison BOCES and Cortland-Madison BOCES Boards of Education has been to encourage that all 23 of the component districts have representation either directly or indirectly. In 1985, an agreement was developed that suggested that the five largest districts have one board member each and that the remaining six board members be nominated by clusters of districts.

Since 1985, one board member has been on the BOCES Board representing the following clusters of districts:

Typically, there has been movement from district to district within each cluster as BOCES Board members end their service.

THE BOCES ANNUAL MEETING

14. **Q. When will the BOCES Annual Meeting be held?**
- A. The BOCES Annual Meeting will be held on Thursday, April 13, 2023, at 6:00 p.m. at the Thompson Road Campus Career & Technical Education Building.
15. **Q. What is the purpose of the Annual Meeting since the election of BOCES Board Members takes place at meetings of the local Boards?**
- A. To present the tentative administrative, capital, and program budgets of the BOCES to component school board members in advance of the vote on the tentative administrative budget and to conduct other BOCES-wide business.

THE VOTE ON THE BOCES ADMINISTRATIVE BUDGET

16. **Q. Where and when must the vote on the BOCES Administrative Budget take place?**
- A. At meetings of the Board of Education of each component school district to be held on April 17, 2023.
17. **Q. Does approval of the tentative administrative budget require approval by a majority of the total number of component Boards of Education or approval of a majority of the Boards of Education that actually vote on the administrative budget?**
- A. While all component Boards are expected to meet and adopt a resolution either approving or disapproving the tentative administrative budget, approval of the administrative budget requires approval of a majority of the number of component Boards actually voting.

18. **Q. When must each board of education report the results of its vote on the administrative budget?**
- A. The resolution either approving or disapproving the tentative administrative budget must be transmitted to Theresa Smith, BOCES Clerk, on April 18, 2023.
19. **Q. How will BOCES budgets be transmitted to local Boards?**
- A. BOCES will email a link to the 2023-2024 BOCES budget posted on the OCM BOCES website to the superintendent's office of local districts for distribution to Board members no later than March 20, 2023.
20. **Q. What must component Boards do after receipt and review of BOCES budgets?**
- A. They must vote only on the administrative budget on April 17, 2023. Districts choose to purchase other BOCES services through the final requests due on April 14, 2023.
21. **Q. What happens if the majority of voting districts approve the tentative BOCES administrative budget?**
- A. The BOCES may adopt the administrative budget without modification.
22. **Q. What happens if the budget is disapproved?**
- A. The BOCES Board must adopt a contingency administrative budget.
23. **Q. Is a contingency administrative BOCES budget the same as an ordinary contingency budget in a local school district?**
- A. No. A contingency administrative budget for BOCES means that the amount of the administrative budget may not exceed the amount in the previous school year, except for additional expenditures incurred in payments for supplemental retirement allowances.
